

Woodrock Fishing Club (WFC)

Rules and Regulations

The mission of the WFC is to enhance the Woodrock outdoor experience by providing fishing opportunities within the community exclusively for Woodrock property owners and their guests. This non-profit club is available for all current Woodrock property owners and long term renters to join. The term "owner" as used herein shall include long term renters so long as the annual assessment on the property is current.

ALL persons fishing in the Woodrock ponds must pay an annual membership and must comply with the following established rules and regulations.

I. PERMIT FEES:

1. ADULT FEES:

- a. \$135 annually if paid by May 18th otherwise \$150 annually, (include Member and spouse, children residing in the household under age 19 and **up to four guests with owner present**) PLUS \$100 initiation fee for new members

- OR -

- b. \$90 annually if paid by May 18th otherwise \$100 annually (includes Member and spouse, children residing in household under age 19 and who do not plan to bring in any guests during the fishing season) PLUS \$100 initiation fee for new members. You may accompany up to four guests for a fee of \$10 per person per day; money to be put into box at the gate.
- c. WFC fees are paid on an annual basis for the period from April 1st through March 31st.

2. ADULT CHILDREN FEES: (residing in the Woodrock household)

- a. Children age 19 and older - \$50 annually

II. RULES AND REGULATIONS:

1. DAILY BAG, POSSESSION AND SIZE LIMITS:

- a. **Fish must be over 12 inches to keep**
- b. Three (3) fish per adult member and one (1) fish per adult guest per day
- c. Three (3) fish per child and one (1) fish per child guest per day
- d. Beginning September 15th of each year and ending on the day of the first stocking of the next year, daily bag, possession and size limits **do not apply.**

2. When catching and releasing, please use care when returning fish to the water. Use single barbless hooks. The use of a wet rubber net ensures minimal impact to the fish. Do not return fish to the water that are injured. If the fish has swallowed the hook, cut the line and return the fish to the water.

3. ICE FISHING:

- a. Ice Fishing is allowed on the upper ponds. Motor vehicles are not allowed on the ice other than to clear the ponds for ice skating.
- b. Woodrock is not responsible for lost or damaged personal property or personal safety while on the ice. **PROCEED AT YOUR OWN RISK!**
- c. Ice fishing holes shall not exceed 10 inches in diameter.
- d. Fires are not allowed.
- e. All litter must be removed.
- f. All ice fishing shelters must be removed at the end of the day.
- g. Only ice augers and handsaws are permitted for cutting holes in the ice.

III. GENERAL:

1. Use of live fish, including minnows, as bait is prohibited in all ponds.
2. Artificial lures, flies, live worms, grubs and power bait are allowed.
3. Use of artificial light is prohibited in all ponds.
4. Use single barbless hooks and a wet rubber net to minimize unnecessarily killing fish.
5. The Woodrock POA annual dues must be paid in full and up to date in order to join the fishing club.
6. A Colorado fishing license is not required.
7. Any person(s) fishing without paying member fees will be required to leave immediately.
8. Fishing is permitted during the hours 30 minutes before sunrise through 30 minutes after sunset.
9. All trash must be hauled out.
10. We are guests on the Myrick property. If the gate is closed when you arrive, be sure to reclose the gate when you enter and when you leave.
11. The upper four (4) ponds are designated for Woodrock member use. The ponds to the left and immediate right of Myrick's homestead property are not authorized for use.
12. Please enter the amount of fish you take out at the front gate log station near the ponds. This helps with determining when it will be necessary to re-stock.
13. Wading and swimming in the ponds is prohibited. (dogs ok, but members wanting to fish have priority).
14. Use of canoes, kayaks and other floating devices is prohibited except for pond cleaning.
15. It is the responsibility of parents to ensure the safety of their children while they are fishing at the ponds.
16. The WFC reserves the right to change any of the membership rules and regulations with written notice to the membership. Publication on the WR website will be deemed adequate notice.
17. The WFC reserves the right to terminate the membership of any member for cause, by notifying the member of the termination in writing. If membership termination occurs, the membership fee will not be refunded.
18. Property owners are responsible for making sure their guests are aware of these rules. Guests must be accompanied by the owner.
19. New property owners may obtain an annual permit transfer from the previous property owner. The WFC Committee must be notified so records are updated.

IV. SECURITY:

1. Cameras have been installed around the ponds to provide additional security.
2. Failure to comply with rules and regulations can result in a fishing permit suspension for up to one year from the date of the infraction.
3. Members of the WFC are encouraged to report any unauthorized use.
4. Please report any complaints, questions or concerns to any member of the WFC Committee.
